

INTERIM & FINAL RELEASE OF LIEN INSTRUCTIONS

"Interim & Final Waiver and Release of Liens and Claims Upon Payment" where Caliber is requiring a Contractor, Subcontractor, design professional, material supplier or other person or entity (the "Company") to provide an interim lien waiver with its Application for Payment.

NOTES:

This interim & final lien waiver form must be submitted by all Contractors/Subcontractors irrespective of the value of their Work and first-tier material suppliers for purchases in excess of \$5,000.00, but is not required for (1) Architects, Engineers, other design professionals and consultants, (2) material suppliers, and vendors, and (3) material suppliers and vendors who have supplied General Condition's materials, equipment and facilities.

Depending on the particular Project, Caliber may wish to require one of these "exempt" entities to provide an interim lien waiver with its request for progress payment.
